# PRODUCTION OF DOCUMENTARY SHORT FILMS TO SHOWCASE THE POTENTIAL OF THREE COMMODITY CLUSTERS

#### PURPOSE

SANASA International is looking for a VIDEO PRODUCTION COMPANY to delegate a short-term mandate to develop Documentary short films on three commodity clusters, as part of the education/promotion programme for the potential investors.

#### **INTRODUCTION**

Sanasa International (Pvt.) Ltd has partnered with Asian Farmers Association for Sustainable Agriculture to implement the APFP/FO4A project which is locally branded as the Smart Farmers project. The key objective of the project is to improve the knowledge and capacities of the small holder farmers and their farm organizations to engage in market aligned businesses that can improve their income. The project is working with 215 farmer collectives under 6 commodity clusters.

One of the main interventions of the project is to support the newly formulated or capacity enhanced farmer cooperatives to find investors and business partnerships for their businesses which they have incubated with the assistance of SEFEC. SANASA International has arranged to organize an investor forum in December to showcase these businesses that the farmer cooperatives are engaged in with the hope to establish long term business partnerships between farmer cooperatives and market leaders/ investors.

To enable the investors to better understand the scope and the potential of the commodity clusters and the partnerships, sanasa International would like to create three documentaries that can illustrate the richness and the potential of each commodity cluster the farmers are working with.

## 1. OBJECTIVES

- Through the above Documentary short films, we plan to tell a previously untold story to the investors and market leaders about the scope of the commodity cluster, the diversity and current challenges faced by the value chain actors and the potential and future opportunities that can be created by collaborating with co-operatives.
- The short films will be mainly supporting in advocacy work and market expansion work, undertaken by the Farmers organizations by showcasing the role cooperative enterprises have been playing and can play to improve supply and market chains in Sri Lanka.

# 2. SCOPE OF THE CONSULTANCY:

The 3 videos will cover the cereal and legume cluster, spices cluster and yam cluster. All three videos will focus on the market space, and the opportunities for expansion and value addition. The videos will cover the point of view of the market leaders, regulators, cluster promoters and Farmers. Ultimately the video will communicate the importance of organizing farmers and establishing formal partnerships with them to strengthen the supply and value chains and increase the resilience of the local economy. The video will talk about nutrition, local economy, and sustainable food production.
